NOTIFICATION BY THE HIGH COURT OF JUDICATURE AT BOMBAY

ORIGINAL SIDE

No. G/Amend/825/2025.—In exercise of the powers conferred by clause (2) of Article 229 of the Constitution of India, with the approval of the Hon'ble Governor of Maharashtra, hereby makes the following amendments in the Bombay High Court Original Side Service Rules, 2002 :—

Insert following clauses after the existing Rule 3 (b) (i) of the Bombay High Court Original Side Service Rules, 2002 :—

Rule 3 (b) (ii) :

" The post mentioned at Sr. No. 15A, namely, Senior Private Secretaries to the Hon'ble Judges, shall carry pay scale of Senior Civil Judge, ACP-I i.e. Rs. 43690-1080-49090-1230-56470 with admissible allowances and perquisites including retirement benefits and service conditions as may be revised and made applicable from time to time, with effect from 1st October 2007.

Rule 3 (b) (iii) :

The post at Sr. Nos. 24, namely, Private Secretaries to the Hon'ble Judges, shall carry pay scale of Pay Band 3 – 15600-39100 + Grade Pay Rs. 7900 with effect from 1st October 2007 and post at Sr. No. 27, namely, Personal Assistants to the Hon'ble Judges, shall carry pay scale of Pay Band 3 – 15600-39100 + Grade Pay Rs. 6600, with effect from 1st October 2007."
