NOTIFICATION

No. X(Gen)-1603/2025/1286.—In partial modification in abovesaid notifications, for declaring holidays, vacations and Court working days for the year 2025, the Hon'ble the Chief Justice has been pleased to modify the Clause 5 of the said Notification dated 18th November, 2024 as follows :-

5. During the Summer, Diwali and Christmas Vacations, the Offices on the Original side will remain open daily from **11.00 a.m. to 5.00 p.m.** except on Saturdays, Sundays and holidays. But no work, except of an urgent nature, will be received after **4.15 p.m.**

The offices on the Appellate Side will also remain open daily from **11.00 a.m. to 5.00 p.m.** except on Saturdays, Sundays and holidays during the Summer, Diwali and Christmas Vacations. The offices will however, remain closed for filing of Judicial matters, except the following :—

- (a) Criminal Cases.
- (b) Applications in Civil Cases seeking urgent relief.
