NOTIFICATION

MAHARASHTRA FORESTS PRODUCE (REGULATION OF TRADE) ACT, 1969.

No. Tendua-2025/C.R.-94/F-9.— In exercise of the powers conferred by sub-sections (1), (2) and (5) of the section 6 of the Maharashtra Forests Produce (Regulation of Trade) Act, 1969 (Mah. LVII of 1969), the Government of Maharashtra hereby constitutes the Advisory Committee in respect of Tembhurni / Tendu (*Diospyros melanoxylon*) for the year commencing on the 1st July 2025 and ending the 30th June, 2026 for the purpose of advising the State Government in the matter of :-

(i) Fixation of a fair and reasonable price at which the Tembhurni / Tendu (*Diospyros melanoxylon*) leaves may be purchased by the State Government or its authorised officers or agent appointed for the purpose, and

(ii) Fixation of charges of collection of the aforesaid leaves from Government lands.

The constitution of the said Advisory Committee shall remain as follows :-
