In exercise of powers conferred under sub-section (3) of Section 4 of the Census Act, 1948 (37 of 1948) Government of Maharashtra are also pleased to authorize all the authorities mentioned in column 2 of the Schedule, who have been appointed as Principal Census Officers or Charge Census Officers in column 3, to sign declaration referred to in the sub-section (3) with respect to persons appointed as census officers for the areas respectively specified against their names in column 4 of the Schedule.

In exercise of the powers conferred by sub-section (4) of Section 4 of the Census Act, 1948 the Government of Maharashtra further are also pleased to delegate the powers of appointing census officers conferred by sub-section (2) of section 4 of the said Act to the authorities specified in column (2) of the Schedule, who have been appointed as Principal Census Officers or Charge Census Officers in column 3, within the area respectively specified against them in column 4 of the said schedule.

In exercise of the powers conferred under sub-section (1) of section 6 and section 7 of the Census Act, 1948 the Government of Maharashtra hereby appoints the Collectors of the districts and Municipal Commissioners shown at Sl. No. 2 and 4 of the Schedule to be the authorities for purposes of sections 6(1) and 7 of the Census Act, 1948 within their respective jurisdiction.

In exercise of the powers conferred by section 12 of the Census Act, 1948, the Government of Maharashtra hereby authorises the authorities mentioned in column 2 against Sl. Nos. 2 and 4 of the Schedule for the areas respectively specified against them in column 4 of the Schedule to give previous sanction to the institution of prosecution under the said Act.
