



DECISION (EU) 2025/829 OF THE SINGLE RESOLUTION BOARD

of 14 April 2025

**on discharge in respect of the implementation of the budget and on the closure of the accounts of the
Single Resolution Board ('SRB') for the financial year 2023 (SRB/PS/2025/06)**

THE SINGLE RESOLUTION BOARD,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 806/2014 of the European Parliament and of the Council of 15 July 2014 establishing uniform rules and a uniform procedure for the resolution of credit institutions and certain investment firms in the framework of a Single Resolution Mechanism and a Single Resolution Fund and amending Regulation (EU) No 1093/2010⁽¹⁾ and in particular, Articles 50(1)(b) and 63(8) of the SRM Regulation,

Having regard to Article 97, 98 and 99 of the SRB Financial Regulation of 17 January 2020, as amended by the Decision Amending SRB Financial Regulation (SRB/PS/2025/02) of 6 February 2025,

Having regard to the SRB Work Programme 2023 as adopted on 28 September 2022 (the '2023 Work Programme'),

Having regard to the Final Annual Accounts of the SRB for the financial year 2023 as adopted on 28 June 2024 (the '2023 Final Annual Accounts'),

Having regard to the Annual Report of the SRB for the financial year 2023 as adopted on 7 June 2024 (the '2023 Annual Report'),

Having regard to the European Court of Auditors' Report on EU agencies for the financial year 2023, including the 'Appendix to the SRB specific annual report, reporting on the SRM contingent liabilities of the SRB', together with the SRB's reply (the '2023 Court of Auditors' Annual Report'),

Having regard to the Report on the 2023 Final Annual Accounts including audit opinions dated 24 June 2024 prepared by Mazars Réviseurs d'Enterprises (the 'Mazars 2023 Audit Report'),

Having regard to the Internal Audit Annual Report 2023 dated 12 January 2024,

HAS ADOPTED THIS DECISION:

Sole Article

1. Grant the Chair of the Single Resolution Board discharge in respect of the implementation of the SRB's budget for the financial year 2023;
2. Approve the closure of the accounts of the SRB for the financial year 2023;
3. Set out its observations in the motion below;
