No. KPV-64-DC-ELC-L-4-TP-14-2025:- Vide Notification No. KPV-51-DC-ELC-L-4-TP-14-2025, dated 9th September, 2025 the total number of members reservation for SC, ST, SEBC, number of unreserved seats, reservation for women belonging to each of the SCs, STs, SEBCs and number of women in unreserved categories (General) seats for Veraval Taluka Panchayat of Girsomnath district have been notified.

AS per Collector, Girsomnath letter no. ELC/GP/No. of Population/09/2025, dated : 20th September, 2025 the total population of Veraval Taluka has been revised and therefore, total number of seats has to be re-fixed as per provision of section-10(4) of the Gujarat Panchayat Act, 1993 (Guj. 18 of 1993).

In exercise of the powers of the State Government under Section 10 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), conferred on me under Government Notification of Panchayats and Rural Housing Department No. KP/191 of 1994/DEL-1094-1246-J, dated 26/7/1994, I, Hitesh Koya, IAS, Development Commissioner, Gujarat State hereby in respect of Girsomnath District in Gujarat State,

state that Veraval Taluka Panchayat shall show total number of members, reservation for Scheduled Castes, Scheduled Tribes, Socially and Educationally Backward Classes and number of unreserved seats, reservation for women; for each of the SCs, STs, SEBCs and for women in unreserved categories (General) as shown in column for Veraval Taluka Panchayat. The number of seats under different categories shall be shown as Scheduled Appended to this Notification.
