#### CONSTITUTION OF INDIA.

**No. GVS/1160/E/13(21)(2)/5522:** In exercise of the powers conferred by clause (3) of article 187 of the constitution of India, the Governor of Gujarat, after consultation with the Speaker of the Gujarat Legislative Assembly, hereby makes the following rules further to amend the Gujarat Legislature Secretarial Staff (Recruitment and Conditions of service) Rules, 1974, namely:-

1. (1) These rules may be called the Gujarat Legislature Secretarial Staff (Recruitment and Conditions of Service) (Amendment) Rules, 2025.
- (2) They shall come into force on the date of their publication in the *Official Gazette*.
2. In the Gujarat Legislature Secretarial Staff (Recruitment and Conditions of service) Rules, 1974, for rule-17, the following rule shall be substituted, namely:-

“17. Appointment to the post of Assistant Librarian.

- (1) Appointment to the post of Assistant Librarian, Class-III in subordinate services of the Gujarat Legislature Secretariat shall be made by the Speaker by direct selection;
- (2) To be eligible for appointment by direct selection to the post mentioned in sub rule (1), a candidate shall, -
  - (a) not be more than 36 years of age:

Provided that the upper age limit may be relaxed in favor of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

- (b) Possess a bachelor's degree in the Library and Information science or Library Science Obtained from any of the Universities or institutions established or incorporated by or under the Central or a state Act in India; or any other educational Institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;
- (c) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (d) possess adequate knowledge of Gujarati or Hindi or both.
- (3) The provisions of rule 9-A of the Gujarat Civil Services Classification and Recruitment (General) rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
- (4) The candidate appointed by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government.
- (5) The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by Government.”

૧. (૧) આ નિયમો ગુજરાત વિધાનસભા સચિવીય કર્મચારીગણ (ભરતી અને નોકરીની શરતો) (સુધારા) નિયમો, ૨૦૨૫ કહેવાશે.
- (૨) આ નિયમો સરકારી રાજપત્ર / ગેઝેટમાં પ્રસિદ્ધ થયાની તારીખથી અમલમાં આવશે.

૨. ગુજરાત સચિવીય કર્મચારીગણ (ભરતી અને નોકરીની શરતો), નિયમો, ૧૯૭૪ના નિયમ-૧૭ને બદલે નીચે મુજબનો નિયમ મૂકવામાં આવે છે, એટલે કે :-

“૧૭. મદદનીશ ગ્રંથપાલની જગ્યા પર નિમણૂક.

(૧) ગુજરાત વિધાનસભા સચિવાલયની વર્ગ-૩ના તાબા હેઠળની મદદનીશ ગ્રંથપાલ, વર્ગ-૩ની જગ્યા પર નિમણૂક અધ્યક્ષ દ્વારા સીધી પસંદગીથી કરવામાં આવશે.

(૨) પેટા નિયમ (૧)માં દર્શાવેલી જગ્યા પર સીધી પસંદગીથી નિમણૂક મેળવવાપાત્ર થવા માટે, ઉમેદવાર:-

(ક) ૩૬ વર્ષથી વધારે વયના હોવા જોઈશે નહીં:

પરંતુ, ગુજરાત મુલ્કી સેવા વર્ગીકરણ અને ભરતી (સામાન્ય) નિયમો, ૧૯૬૭ની જોગવાઈઓને અનુરૂપ ગુજરાત સરકારની સેવામાં પહેલેથી જ કાર્યરત હોય તેવા ઉમેદવારની તરફેણમાં ઉપલી વયમર્યાદામાં છૂટછાટ આપી શકાશે.

(ખ) ઉમેદવાર ભારતમાં કેન્દ્રીય કે રાજ્ય અધિનિયમ દ્વારા અથવા તેની હેઠળ સ્થાપિત કે સમાવિષ્ટ કોઈપણ યુનિવર્સિટી કે સંસ્થા અથવા યુનિવર્સિટી ગ્રાન્ટ્સ કમિશન અધિનિયમ, ૧૯૫૬ની કલમ-૩ હેઠળ યુનિવર્સિટી તરીકે માન્યતાપ્રાપ્ત અથવા જાહેર કરવામાં આવેલી અન્ય કોઈપણ શૈક્ષણિક સંસ્થા તરફથી મેળવેલી ગ્રંથાલય અને માહિતી વિજ્ઞાન અથવા ગ્રંથાલય વિજ્ઞાનમાં સ્નાતકની પદવી ધરાવતા હોવા જોઈશે.

(ગ) ગુજરાત મુલ્કી સેવા વર્ગીકરણ અને ભરતી (સામાન્ય) નિયમો, ૧૯૬૭માં નિયત કર્યા અનુસાર કોમ્પ્યુટરનું પાયાનું જ્ઞાન ધરાવતા હોવા જોઈશે, અને

(ઘ) ગુજરાતી અથવા હિંદી અથવા બન્ને ભાષાનું પૂરતું જ્ઞાન ધરાવતા હોવા જોઈશે.

(૩) સીધી પસંદગીથી નિમણૂક પામેલા ઉમેદવારના કિસ્સામાં ગુજરાત મુલ્કી સેવા વર્ગીકરણ અને ભરતી (સામાન્ય) નિયમો, ૧૯૬૭ના નિયમ ૯-કની જોગવાઈઓ લાગુ પડશે.

- (1) for the words “by promotion of a person of proved merit and efficiency” the words and signs “by promotion of a person who possesses ‘Good’ benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.” shall be substituted.
- (2) sub- clause (ii) shall be deleted.
3. In the said-rules, in rule 3, in clause (b), for the words and figures “class III, in the Government” the words and figures- “class III, in the subordinate service of the Directorate of Animal Husbandry” shall be substituted.

**No. GKH/182/2025/ACD/FDE/e-file/2/2024/7091/Z:** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Administrative Officer, Class II, in the General State Service, under the Commissionerate of Fisheries, Gujarat State, namely:-

1. (1) These rules may be called the Administrative Officer, Class II, in the General State Service under the Commissionerate of Fisheries, Recruitment Rules, 2025.
- (2) They shall come into force from the date of their publication in the *Official Gazette*.
2. Appointment to the post of the Administrative Officer, Class II, in the General State Service, under the Commissionerate of Fisheries shall be made by promotion of a person who possess ‘Good’ benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons who –
  - (i) have worked for not less than seven years in the cadre of Office Superintendent, Class III, in the subordinate service of the Commissionerate of Fisheries, Gujarat State;
  - (ii) have passed the prescribed departmental examination; and
  - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above.

3. The candidate appointed by promotion shall be required to undergo such training and to pass such examination as may be prescribed by the Government.
