Varadhan Vs. Union of India & Anr., and order dated 08/12/2025 in Writ Petition (Civil) No.581/2024 in the case of Yogamaya M.G. Vs. - # The Rules provides of this # programme and the same has been provided in compliance with Rules (6) Bar Council of Gujarat Election Rules.
- ## In view of the letter dated 23/12/2025 of the Bar Council of India, which states that as the strength of Bar Council of Gujarat is 25, 7 seats comprising 5 seats to be filled up through election and 2 seats through co-option by the Bar Council of India. In these circumstances, there will be election of only 23 members of Bar Council of Gujarat, out of which, 5 seats of women would be represented by elected members.

The Nomination paper shall be delivered to the Returning Officers either personally or through an agent or sent by Registered post at the office No. A-102, Bar Council of Gujarat office, Satyamev Complex, Opp. High Court of Gujarat, Sola, Ahmedabad so as to reach the Returning Officers at the Bar Council of Gujarat Office on or before **07/02/2026 (Saturday) before 5.00 p.m.**
3. Every Nomination paper shall be accompanied by **non-refundable** sum of **Rs. 1,25,000/- (Rupees One Lac Twenty Five Thousand only)** by way of Demand Draft (drawn in favour of “Bar Council of Gujarat Election Provision Fund”) or through RTGS/NEFT so as to reach on or before **07/02/2026 (Saturday) before 5.00 p.m.; as per the letter dated 25/09/2025 of the Bar Council of India.**
