In exercise of the powers conferred by Article 229 (2) of the Constitution of India, the Honourable the Chief Justice has been pleased to make the following amendments in the High Court of Gujarat (Recruitment and Conditions of Service of Officers and Staff) Rules, 2011:-

1. Short title and commencement:

- (i) These Rules may be called "The High Court of Gujarat (Recruitment and Conditions of Service of Officers and Staff) Amendment Rules, 2026". [Amendment 1 of 2026]
- (ii) They shall come into force with immediate effect.
