In exercise of the powers conferred by Article 229 (2) of the Constitution of India, the Honourable the Chief Justice has been pleased to make the following amendments in the High Court of Gujarat (Recruitment and Conditions of Service of Officers and Staff) Rules, 2011:-

1. Short title and commencement:

- (i) These Rules may be called "The High Court of Gujarat (Recruitment and Conditions of Service of Officers and Staff) Amendment Rules, 2026". [Amendment 2 of 2026]
- (ii) They shall come into force with immediate effect.

2. Following Para shall be inserted after the words "shall be made as provided in (ii) above." appearing in Rule-6[A](iii):

"(iv) The Select List may be prepared strictly on the basis of Aggregate Marks obtained in the Written Test and/or the Stenography/Skill Test and /or the Viva voce Test (Oral Interview), whichever is applicable.

The Wait List shall be prepared in respect of Group-C and Group-D posts, which shall remain in force for a period of 03 (Three) months from the date of its publication and may be operated only in case, the candidate/s of the Select List does not accept the offer of appointment within the time limit."

3. Following amendments are carried out in SCHEDULE-D of 'The High Court of Gujarat (Recruitment and Conditions of Service of Officers and Staff) Rules, 2011' :-
