और केन्द्रीय सरकार को ऐसी पाईपलाइन बिछाने के प्रयोजन के लिये यह आवश्यक प्रतीत होता है, कि उस भूमि में जिसके भीतर उक्त पाईपलाइन बिछाई जाने का प्रस्ताव है, जो इस अधिसूचना से सलग अनुसूची में वर्णित है, उपयोग के अधिकार का अर्जन किया जाए

New Delhi, the 7th October, 2020

S.O. 3539(E).—Whereas, it appears to the Central Government, that it is necessary in the public Interest that for the transportation of Petroleum Product from Kandala to Gorakhpur in the state of Madhya Pradesh Pipeline should be laid by IHB Private Limited;

And Whereas, it appears to the Central Government that for the purpose of laying such pipeline, it is necessary to acquire the right of user in land under which the said pipeline is proposed to be laid, and which is described in the Schedule annexed hereto;

Now therefore, in exercise of the powers conferred by Sub-section (1) of Section 3 of the petroleum and Minerals Pipeline (Acquisition of Right of user in Land) Act, 1962 (50 of 1962), the Central Government hereby declares its intention to acquire the right of user there in;

Any person interested in the land described in the said schedule may, within twenty one days from the date on which copies of the Gazette of India Containing this notification are made available to the general public, object in writing to the acquisition of the right of user therein for laying of the pipeline under the land to competent Authority, IHB Private Limited.
