NOTIFICATION

New Delhi, the 6th November, 2024

G.S.R. 706(E).—In exercise of the powers conferred by clause (2) of Article 146 of the Constitution, the Chief Justice of India hereby makes the following amendments to the Supreme Court Officers and Servants (Conditions of Service and Conduct) Rules, 1961 with effect from 05.11.2024:-

The existing Category No.46 (Chauffeur) will be substituted with the following :-

(1) The cadre structure and grade for existing incumbents holding the post of Chauffeur shall be as under :-

46C	Assistant Chauffeur (38% of cadre)	-do-	By direct Recruitment	---
