Amendment to the Tamil Nadu Allied and Healthcare Profession Rules, 2023.

No. SRO A-21/2025.—In exercise of the powers conferred by section 68 of the National Commission for Allied and Healthcare Professions Act, 2021. (Central Act 14 of 2021), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Allied Healthcare Profession Rules, 2023, namely:-

AMENDMENT.

In the said Rules:-

(1) In the rule 3, in the TABLE, in column (3), -

- (a) Against Serial Number "(3)" in column (1) and against the entry "Physiotherapy Professional" in column (2),-
 - (i) the item "(iii) A diploma in Physiotherapy with not less than 25 years of experience, or" shall be omitted;
 - (ii) item (iv) shall be renumbered as item (iii);
- (b) against Serial Number "(6)" in column (1) and against the entry "Occupational Therapy Professional" in column(2),-
 - (i) the item "(iii) A diploma in Occupational Therapy with not less than 20 years of experience; or" shall be omitted;
 - (ii) item (iv) shall be renumbered as item (iii);

(2) in rule 14, -

- (a) sub-rule (2) shall be omitted;
- (b) sub-rules (3), (4), (5), (6), (7), (8) and (9) shall be renumbered as sub-rules (2), (3), (4), (5), (6), (7) and (8) respectively;
- (c) in sub-rule (5) as so renumbered, for the expression sub-rule (5)", the expression "sub-rule(4)" shall be substituted;

(3) in FORM - I, -

- (a) for the expression "(see rule 14(1) & (2)", the expression "(see rule 14(1))" shall be substituted;
- (b) for the word "Technician", the word "Category" shall be substituted;
- (c) the following item shall be omitted, namely:-

"4. Character Certifier's name and address:

 - 1.
 - 2.

Character certificates (two)"; and
- (d) Item 5 shall be renumbered as item 4.
