Variation to the Approved Thanjavur Master Plan for the Thanjavur Local Planning Area*(Roc No: GC2UCZLA /518/2025TD3)*

No. VI(1)/496/2025.

In exercise of the powers conferred by sub-section (4) of section 32 of the Tamil Nadu Town and Country Planning Act 1971 (Tamil Nadu Act 35 of 1972) and also in exercise of powers conferred by Government Order Ms.No:94, Housing and Urban Development (UD(4)1) Department dated 12.06.2009 published in *Tamil Nadu Government Gazette* No:27, Part II — Section 2, in Page No:228 dated 15.07.2009, the following variations are made to the Master Plan for Thanjavur Local Planning Area Approved under the said Act and published in the Housing and Urban Development Department Notification at page No:879 of Part VI-Section 2 of *Tamil Nadu Government Gazette* date 11th October 1995.

VARIATIONS

In the said Master Plan in the "LAND USE SCHEDULE" under the heading "Thanjavur Local Planning Area, Manakarabai Village"

- i) Against the "Agricultural Wet use zone (AGW-3)" S.F.No.114/3 shall be deleted
- ii) Against Educational use (E-14) the S.F.No. 114/3 shall be added

condition:

(i) Since a water way runs through the proposed land as the field map (FMB) the development should be carried out by rerouting the water way within the boundaries of the land and maintaining the structure of this water way on the land. Further more, appropriate procedures should be followed for developments carried out along water bodies.

(ii) As stated in the Local Planning Authority Resolution No.19, Dated:11.12.2024, the petitioner is required to provide an access road with sufficient width to the Government Field and outlying land in survey No.115/5 while granting planning permission for development.

(iii) As the site inspection report states that a school building is operating on the proposed site, appropriate planning permission should be obtained for the existing school building.

(iv) Development works should be carried out as per Tamil Nadu Combined development and Building Rules 2019.
