The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below to be acquired for Highways for the purpose to wit for the Construction of road over bridge in lieu of existing Level Crossing No.48 at Railway KM 77/700 – 800 between Nagore and Nagapattinam Railway Stations at KM.0/2 of Nagapattinam – Akkaraipettai – Velanganni Road in Nagapattinam Town of Nagapattinam Taluk & District and it having already been decided that the amount of compensation to be awarded for the land is to be paid out of the funds controlled and managed by Divisional Engineer, Highways (Schemes), Thanjavur.
