Class II – Other Members – Sub-Sec. (b) (2) of Section 24 under Chapter IV of the Bharathidasan University Act, 1981 - Two Members elected by Teachers of Affiliated Colleges other than Principals from among themselves who are members of the senate, in accordance with the system of proportional representation by means of the single transferable vote.
