JUDICIAL NOTIFICATION

Conferment of Magisterial Powers on certain Revenue Officials

(Roc. No. 111320/2025/B6)

No.VI(1)/637/2025.

No.217/2025.—In exercise of the powers conferred under Section 11 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act No.46 of 2023), the High Court hereby appoints the following (i) **8 Deputy Tahsildars in Tiruvallur District**, (ii) **4 Deputy Tahsildars in Ariyalur District** (iii) **4 Deputy Tahsildars in Kallakurichi District** and (iv) **8 Deputy Tahsildars in Tiruchirappalli District**, as Special Judicial Magistrates, to undergo Magisterial Training for a period of **120 days** from the date of assumption of charge and confers upon them the ordinary powers conferable under this Code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.
