NOTIFICATION

No. 100/KT-LA/2/2026:- **WHEREAS**, the seat of **Sri. Shamanur Shivashankarappa**, in the Legislative Assembly of the State of Karnataka elected from **107-Davanagere South** Assembly Constituency, has become vacant on 14th December, 2025, by reason of his death: and

2. **WHEREAS**, a bye-election has to be held for the purpose of filling the vacancy so caused;

3. **NOW, THEREFORE**, in pursuance of sub-section (1) of Section 150, Section 30 and Section 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-

(A) **calls upon** the said **107-Davanagere South** Assembly Constituency in the State of Karnataka, to elect, before 6th May, 2026 (Wednesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for purpose of filling the said vacancy in the Legislative Assembly of the State;

(C) **fixes the hours** from 7:00 A.M. to 6:00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
