DECISION OF THE EEA JOINT COMMITTEE No 132/2026
of 30 April 2026
amending Annex II (Technical regulations, standards, testing and certification) to the
EEA Agreement [2026/1480]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ("the EEA Agreement"), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) 2025/2068 of 15 October 2025 renewing the approval of the active substance milbemectin in accordance with Regulation (EC) No 1107/2009 of the European Parliament and of the Council, and amending Commission Implementing Regulation (EU) No 540/2011 ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Annex II to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Chapter XV of Annex II to the EEA Agreement is amended as follows:

1. The following indent is added in point 13a (Commission Implementing Regulation (EU) No 540/2011):
‘— **32025 R 2068:** Commission Implementing Regulation (EU) 2025/2068 of 15 October 2025 (OJ L, 2025/2068, 16.10.2025).’
2. The following point is inserted after point 13zzzzzzzzzzzzzzzn (Commission Implementing Regulation (EU) 2025/1879):
‘13zzzzzzzzzzzzzzo. **32025 R 2068:** Commission Implementing Regulation (EU) 2025/2068 of 15 October 2025 renewing the approval of the active substance milbemectin in accordance with Regulation (EC) No 1107/2009 of the European Parliament and of the Council, and amending Commission Implementing Regulation (EU) No 540/2011 (OJ L, 2025/2068, 16.10.2025).’

Article 2

The text of Implementing Regulation (EU) 2025/2068 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 1 May 2026, provided that all the notifications under Article 103(1) of the EEA Agreement have been made ^(*).
