

COMBINED MEDICAL SERVICES EXAMINATION, 2025

Based on the result of the Written Examination (Part-I) of the Combined Medical Services EXAMINATION, 2025 held by the UNION PUBLIC SERVICE COMMISSION on 20th July, 2025 followed by Personality Test (Part – II) held from October to December, 2025, the following lists of the candidates who have been recommended for appointment to the services/posts under two categories are appended:

Medical Officers Grade in General Duty Medical Officers Sub-cadre of Central Health Service;

- (a) Assistant Divisional Medical Officer in the Railways;
