4. Intending bidders are required to deposit for participating in the auction, a refundable caution deposit of Rs. 1,00,000/- (Rupees One Lakh only) with the auctioneer.
5. 25% of the final bid amount has to be paid immediately by the successful bidder as soon as knocking down of the auction in his/her favour and the balance 75% of the final sale value along with applicable poundage fee is required to be paid on or before 15 days from the date of sale of the property.
