STATE LEVEL MULTIMEMBER APPROPRIATE AUTHORITY (SLMMAA) FOR
IMPLEMENTATION OF PC & PNDT ACT, 1994.

NOTIFICATION

Government, after careful examination of the matter, hereby Reconstitution of State Level Multi Member Appropriate Authority under section 17, Sub Section (3) and clause (i) (ii) of the Pre-Natal Diagnostic Techniques (Regulations of Mis-Use) Act, 1994 and Rules, 1996 i.e., Pre-Conception and Pre-Natal Diagnostic Techniques (Prohibition of Sex Selection Act), 1994 and Rules 1996 by issuing Notification comparing with the following members:

TERMS AND CONDITIONS:

- I. The Appropriate Authority shall meet at least once in sixty days.
- II. Whenever the Chairperson / Chairman feel that convening of Appropriate Authority meeting may be essential and depending upon the necessity or in any case of emergency situation, special meeting may also be convened.
- III. The term of the Appropriate Authority in case of other than ex-officio Member (non-official member) (Sl. No. iii) will be 3 (three years).
- IV. The remaining appropriate authorities i.e. Sl No. (i) Chairperson / Chairman and (iii) Officer nominated by Law Deptt; will be permanent and unchanged authority.
- V. The reconstitution of Multi-Member Appropriate Authority will be done by the State Supervisory Board / Government on the basis of recommendation of the Chairperson / Chairman, State Appropriate Authority for PC&PNDT Act or Commissioner of Health & Family Welfare.
- VI. In addition to the District Appropriate Authorities, the State Appropriate Authority can also independently inspect, search & seizure, usage of decoy customer at any registered premises under the Act throughout the State.
- VII. The State Appropriate Authority can create / constitute any number of inspecting teams, task force teams etc., throughout the State depending upon situation, either permanently or temporarily.
- VIII. The Chairman / Chairperson, Multi-Member Appropriate Authority can depute, authorize any person for any purpose connecting with the implementation of the Act.
- IX. The Chairperson / Chairman, State Appropriate Authority has to issue press releases / news articles on implementation of PC&PNDT Act at least once in a month.
- X. Any other assignment as specified by the Government of India, Central Supervisory Board, State Government, State Supervisory Board; Commissioner of Health & Family Welfare or any other statutory authority / body for effective implementation of the Act and Rules in the State.

The Commissioner of Health and Family Welfare, A.P., Mangalagiri, Guntur District shall take further necessary action in the matter.
