These must be filled in accordance with the instructions thereon and returned to the Returning Officer not later than **12.00 noon on Wednesday the 19th November, 2025**. The scrutiny of the nomination papers will take place at 12.00 Noon on Wednesday, the 19th November, 2025 at the office of the Returning Officer. A list of valid nominations will be published in Andhra Pradesh Gazette on Wednesday, the 19th November, 2025. Voting papers and other forms connected there with will be sent by post by the Returning Officer on or before **11th December, 2025** to all electors with instructions printed therein and the voting papers are returnable to the Returning Officer not later than **5.00 PM on Wednesday, the 24th December, 2025** at the office of the Returning Officer. The scrutiny and counting of votes will take place in the office of the Returning Officer from Saturday, the **27th December, 2025 at 10.00 AM and 28th December, 2025**, if necessary.
