MOTOR VEHICLES - ANDHRA PRADESH MOTOR VEHICLES TAXATION ACT, 1963 - RATIFICATION OF TAX EXEMPTION GIVEN FOR 9 VEHICLES FROM 01.07.2022 TO 31.03.2025 AND GRANT OF EXEMPTION FROM PAYMENT OF TAX PAYABLE UNDER AP MOTOR VEHICLES TAXATION ACT 1963 IN RESPECT OF 11 VEHICLES FROM 01.04.2025 TO 31.03.2028 OF THE HOMI BHABHA CANCER HOSPITAL & RESEARCH CENTRE, AGANAMPUDI (V), GAJUWAKA (M).

NOTIFICATION

In exercise of the powers conferred by Sub- Section (1) of Section 9 of Andhra Pradesh Motor Vehicles Taxation Act, 1963 (Act 5 of 1963), the Governor of Andhra Pradesh hereby ratify tax exemption already given for the 9 vehicles bearing Nos. AP39UK0976, AP31TE2000, AP31TE2001, AP31TF6272, AP31TH7442, AP39UD0654, AP39TM9802, AP31TB4567 and AP39TV0753 from 01.07.2022 to 31.03.2025 for an amount of **Rs.4,81,340/- (Rupees Four Lakhs Eighty One thousand Three and Forty only)** as per the provisions of the G.O.Rt.No.129, of TR&B (Tr.1) Dept. Dated.11.11.2011 and also grants exemption from payment of tax payable under the said Act for the said nine (9) vehicles and also for another two(2) vehicles bearing Nos. AP39WA5872 and AP39WA5873 from 01.04.2025 to 31.03.2028 for an

amount of **Rs.9,17,160/-** (Rupees Nine Lakhs Seventeen Thousand One Hundred and Sixty only) in respect of the Homi Bhabha Cancer Hospital & Research Centre, Aganampudi (V), Gajuwaka (M), Visakhapatnam, subject to strict enforcement of the provisions of the G.O.Rt.No.129, of Tr.R&B (Tr.1) Dept. Dated.11.11.2011.

2. The Transport Commissioner, AP, Vijayawada shall take further necessary action in the matter, accordingly.
