II CLASS IN PRAKASAM DISTRICT.

ORDER:-

In the circumstances reported by the Registrar General, High Court of Andhra Pradesh, Amaravati in the letters 4th read above, Government after careful examination of the matter, hereby appoint the following candidates mentioned in column (2) of the Tables given below at the stations shown against their names in column No.(6) thereof as Special Judicial Magistrates of II Class in Prakasam District. The term of appointment for the candidates of Table-I is for a period of One (01) year from the date of assuming charge of the post or till they attain the age of 65 years, whichever is earlier with a consolidated honorarium of Rs.45,000/- per month and Rs.5000/- per month towards conveyance. The term of appointment for the candidates of Table-II will be for a period up to 31st March, 2026, subject to extension of the same by the Government for further period or till they attains the age of 65 years or one year, whichever is earlier, from the date of assuming charge of the post by the officer, on consolidated monthly honorarium of Rs.45,000/- (Rupees Forty Five thousand only) per month and Rs.5,000/- (Rupees Five thousand only) per month towards conveyance in terms of orders issued in G.O.3rd read above, subject to the following conditions:-

- (a) If any of the individual refuses or does not join within Fifteen (15) days from the date of issue of the notification, he/she shall forfeit his/her claim to the post of Special Judicial Magistrate of II Class, forever.
- (b) He/She will be removed from service without being called upon to show cause, if he/she failed to attend three (3) Consecutive sittings of the Court, without written permission of the Chief Judicial Magistrate.
- (C) The services of the officers appointed shall be liable to be terminated at any time without any notice.
