RULES, 1993.

NOTIFICATION

In exercise of the powers conferred by proviso to article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Fisheries Subordinate Service Rules, 1993 issued in G.O.Ms.No.131, AH&F (Fish-I) Department, dated:30.06.1993 and as subsequently amended from time to time.

AMENDMENT

In the Said Rules-

Under Rule-3, in the Table,

For Category-2, in Class-I, the following shall be substituted, namely:-

Category	Name of the Post	Method of Appointment
Class-I Category-2	Assistant Inspector of Fisheries including Assistant Farm Superintendent.	Subject to other provisions in these rules, the method of Appointment, for the several categories shall be as follows: i)By Direct recruitment - 30%. ii)By Recruitment by promotion from Category-3 (A)-40%. iii)By Recruitment by promotion from Category (3)-20%. iv)By Recruitment by transfer of Junior Assistants in the Fisheries Department- 10%. Note:1: If no eligible candidate is available under clause (iii) & (iv), the vacancies shall be filled up with the eligible candidates under Clause (ii) Note:2: In a unit of (10) Vacancies in the posts of Assistant Inspectors of Fisheries including the Assistant Farm Superintendents, the appointments by the different methods of appointment, shall be made in the following orders: 1st Vacancy - By Direct Recruitment 2nd Vacancy - By recruitment by promotion from Category-3 (A) 3rd vacancy - By Recruitment by promotion from Category-3 (A) 4th vacancy - By Recruitment by promotion from Category - 3 5th Vacancy - By recruitment by transfer of Junior Assistants in the Fisheries Dept. 6th Vacancy - By Direct

		Recruitment 7 th Vacancy - By recruitment by promotion from Category-3 (A) 8 th Vacancy - By recruitment by promotion from category – 3 9 th Vacancy - By Direct Recruitment 10 th Vacancy - By recruitment by promotion from Category-3 (A)
