ORDER:

The following extent have been notified U/s 19(1) of RFCTLARR Act, 2013 vide
Collector's Proceedings No. Rc.G2/2284/2020, dt:22-02-2023. The Gazette and
publication details are as follows:

Earlier, as per the request of the Land Acquisition Officer / Revenue Divisional Officer, Vijayawada has requested to extend the draft declaration period for acquiring the lands to an extent of 802.47 Sq.Yrds (Ac.0.16 Cts) in RS.No.96/1B of Bhavanipuram Village of Vijayawada West Mandal which was proposed for the purpose of construction of A1 service road connecting to Kanaka Durga Flyover for a period of 12 months i.e., 06.03.2024 to 05.03.2025 & 06.03.2025 to 05.03.2025 was extended twice vide reference 3rd & 4th read above. Now, the Land Acquisition Officer / Revenue Divisional Officer, Vijayawada has again requested to extend the draft declaration period i.e., 06.03.2025 to 05.03.2026 as the requisition department i.e., Executive Engineer, (R&B) NH-Division, Vijayawada have not been deposited the funds to acquire the lands for the said project.

In this regard, it is once again extending the time of declaration for passing of award U/s 25 RFCTLARR Act, 2013 is as follows:

“The Collector shall make an award within a period of twelve months from the date of publication of the declaration under section 19 and if no award is made with that period, the entire proceedings for the acquisition of the said land shall lapse:

Provided that the appropriate Government shall have the power of extend the period of twelve months if in its opinion, circumstances exist justifying the same:

Provided further that any such decision to extend the period shall be recorded in writing and the same, shall be notified and be uploaded on the website of the authority concerned”.

In view of the above, after careful examination of the proposal received from the Land Acquisition Officer/Revenue Divisional Officer, Vijayawada and as per section 25 of RFCTLARR Act, 2013 the time period for passing of award for the extent notified U/s 19(I) as mentioned in para I are hereby extended for a period of 12 months i.e., 06.03.2026 to 05.03.2027 as the funds are awaited from the requisition department i.e., Executive Engineer (R&B) NH-Division, Vijayawada department for the said acquisition.

The land Acquisition Officer concerned is directed to take decision for notification of the same and upload on the website.
