NOTIFICATION

In exercise of the powers conferred by Section 6 and 9 of the Indian Christian Marriage Act, 1872, the Government of Andhra Pradesh, hereby extends the tenure of Marriage Licenses to the following Eight (08) Pastors/Priests/Evangelists of Kakinada, NTR, East Godavari, Kurnool, Palnadu, and Eluru Districts for further period of Ten (10) years to solemnize the marriage between Indian Christians and to issue Certificate of Marriage in accordance with provisions of the said Act, within the territories comprising the State of Andhra Pradesh:
