The Chairperson may nominate any other suitable person as a Special Invitee to the Council, either for a individual meeting or for a specified period.

The tenure of the members, other than ex-officio members of the State Council shall be for a period of 2 years or till further orders of the Government whichever is earlier.

The State Council shall meet at least once in six months to advise the State Government on effective implementation of the Act and Rules and to perform such functions in relation to Parents and Senior Citizens as may be specified by the State Government.

The Director, Welfare of Differently Abled, Transgender & Senior Citizens, A.P., shall take necessary action accordingly.
