The Chairperson and every Member shall hold office as such for a term of three years from the date on which he/she assumes office (OR) till attaining the age of sixty five years in the case of Chairperson and sixty years in the case of Members whichever is earlier as per Section 19(1) of the Commissions for Protection of Child Rights Act, 2005 (Central Act No.4 of 2006).

3. The above appointments shall be subject to the final outcome of the criminal cases pending against them, if any, in the event of conviction for an offence involving moral turpitude, appropriate action shall be taken as per rules.
4. The Chairperson and Members of Andhra Pradesh State Commission for Protection of Child Rights will be paid honorarium and other allowances as per G.O.Rt.No.196, Dept. for WCDA & SCs (JJ), dated:26.05.2014 read with G.O.Rt.No.247 of the Dept. for WCDA&SCs (Prog.I), dated:04.12.2018.
5. The Director, Women Development & Child Welfare Department, A.P., Guntur shall take necessary action, accordingly, in the matter.
