NOTIFICATION-I

NOTIFICATION-II

In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the Book 1 of CARD of "Table of fee" issued in G.O.Ms.No.463, Revenue (Regn.I) Dept., dated:17.08.2013 and subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" after category 6(a)(x), the following shall be added as 6(b)(i) namely:

6(b)(i) No registration fee shall be levied for execution of sale deed by the Andhra Pradesh Maritime Board in favour of M/s. Indosol Solar Private Limited to an extent of land Ac.52.695 for establishment of a 1GW Plant and for execution of sale agreement to an extent of land Ac 4.26 Cts for establishment of Employees Hostel in favour of M/s. Suryachakra Developers Private Limited, SPV of M/s. Indosol Solar Private Limited as annexed to this order in Chevuru Village of Gudluru Mandal, Prakasam District.
