PROHIBITION OF STRIKES IN THE ESSENTIAL SERVICES OF THE TIRUMALA TIRUPATI DEVASTHANAMS, TIRUPATI UNDER THE PROVISIONS OF THE ANDHRA PRADESH ESSENTIAL SERVICES MAINTENANCE ACT, 1971 FOR A PERIOD OF SIX MONTHS w.e.f. 24.05.2026 TO 23.11.2026.

NOTIFICATION

Whereas, the Government of Andhra Pradesh declared the services in the Water Works Department, Electricity Department, Health and Sanitation Department, Medical Department, Engineering Department (Maintenance Section), Transport Department, Forest Department, Canteen Department including M.T.V. Annaprasada Complex, Vigilance and Security Department, S.V. Dairy Farm (S.V. Gosamrakshanasala) Temple Administration (Queue Complex, Temple, Potu, Local Temples), Kalyanakatta Complex, Sri Venkateswara Institute of Medical Sciences (SVIMS) and its attached institutions, and Sri Padmavathi Children Heart Center, Tirupati, Reception at Tirupati and Tirumala Sri Venkateswara Institute of Medical Sciences (SVIMS) and its attached institutions, Sri Padmavathi Children Heart Centre, Tirupati (SPCHC)" which are under the administrative control of the Tirumala Tirupati Devasthanams, Tirupati as "Essential Services" under Sub-clause (vi) of clause(a) of subsection (1) of Section 2 of the Andhra Pradesh Essential Services Maintenance Act, 1971 (Andhra Pradesh Act of 1971).

2. And whereas, the Government have prohibited strikes in all the said essential services under the control of the Tirumala Tirupati Devasthanams, Tirupati for a period of six months vide G.O.Rt.No.1309, Revenue (Endts.III) Department dated:27.10.2025 and the period of six months expired by 23.05.2026.

3. And whereas the Government is satisfied that, in the public interest, it is necessary and expedient to prohibit strikes in all the above- said essential services under the control of the Tirumala Tirupati Devasthanams, Tirupati for a further period of six months with effect from 24.05.2026 to 23.11.2026.

4. Now, therefore, in exercise of the powers conferred by Section 3 (3) of the Andhra Pradesh Essential Services Maintenance Act, 1971 (Andhra Pradesh Act, 20/71), the Government of Andhra Pradesh hereby prohibit strikes in the aforesaid essential services under the control of the Tirumala Tirupati Devasthanams, Tirupati for a period of six months with effect from 24.05.2026 to 23.11.2026.
