NOTIFICATION

Whereas, a motion expressing 'No Confidence' against Smt.Devi Chindada, Vice-President-II, Mandal Praja Parishad, Munagapaka, Anakapalli District, was moved, under sub section(1) of Section 245 of the Andhra Pradesh Panchayat Raj Act, 1994 (Andhra Pradesh Act, No.13 of 1994) read with G.O.Ms.No.200, Panchay Raj & Rural Development (Mdl.I) Department, Dated:28.04.1998;

2. And whereas, a special meeting of the Mandal Parishad Territorial Constituency Members of the Mandal Praja Parishad, Munagapaka of Ankapalli District, for the purpose of considering the above said 'No Confidence Motion', was held on 04.02.2026 in the premises of the Mandal Praja Parishad, Munagapaka of Anakapalli District;

3. And whereas, when the said Motion was put to vote, it was supported by (11) Mandal Parishad Territorial Constituency Members present, out of the total number of (16) Mandal Parishad Territorial Constituency Members (1 vacant) of the Mandal Praja Parishad, Munagapaka of Anakapalli District and the Motion was passed with the requisite majority;

4. Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 245 of the Andhra Pradesh Panchayat Raj Act, 1994 read with G.O.Ms.No.200, Panchayat Raj & Rural Development (Mdl.I) Department, Dated:28.04.1998, the Government, hereby, remove Smt.Devi Chindada, Vice-President-II, Mandal Praja Parishad, Munagapaka, Anakapalli District, with immediate effect.

5. The Commissioner, Panchayat Raj & Rural Development, Andhra Pradesh, Tadepalli, Guntur District shall take necessary further action, accordingly.
