If any person intends to object, he may submit his objections if any to the Special Tribunal, East Godavari, Rajamahendravaram on or before **16.04.2026** for its consideration.

If no objections are received by the Special Tribunal within the stipulated period, it will be presumed that there were no objections for proceeding further and the case will be proceeded accordingly.
