THE HAZARDOUS AND OTHER WASTES (MANAGEMENT AND TRANSBOUNDARY MOVEMENT) RULES, 2016 - HAZARDOUS WASTE TREATMENT, STORAGE AND DISPOSAL FACILITY (TSDF) SITE LOCATED AT M/s. COASTAL WASTE MANAGEMENT PROJECT (CWMP) (A DIVISION OF M/s. RESUSTAINABILITY LIMITED) (FORMERLY KNOWN AS RAMKY ENVIRO ENGINEERS LTD.), SURVEY No.116/P, THADI VILLAGE, PARAWADA MANDAL, ANAKAPALLI DISTRICT - NOTIFICATION OF A SECURED LAND FILL SITE FOR DISPOSAL OF HAZARDOUS WASTE IN THE BALANCE AREA OF 40 ACRES OUT OF 50 ACRES (i.e., BY EXCLUDING 10 ACRES COVERED UNDER W.P.No.13380 OF 2023) IN SURVEY NO.116/P OF THADI VILLAGE, PARAWADA MANDAL, ANAKAPALLI DISTRICT.

NOTIFICATION

Whereas, the Government of Andhra Pradesh in pursuance of the powers, conferred under Schedule VII of 3 (i, ii, iii & iv) of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 and amendments thereof has undertaken and continuing programme to identify the sites and compile and publish periodically an inventory of disposal sites

within the State for the disposal of Hazardous wastes, Notifying the sites and also Asses Environment Impact Assessment (EIA) reports and convey the decision of approval of site or otherwise Acquire the site or inform operator of facility or occupier or association of occupiers to acquire the site.

Now, therefore, in exercise of the powers conferred under Schedule VII of 3 (i, ii, iii & iv) of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 and amendments thereof, the Government of Andhra Pradesh hereby notify of a Secured Land fill site for disposal of hazardous waste in the balance area of 40 acres out of 50 acres (i.e., by excluding 10 acres covered under W.P.No.13380 of 2023) in Sy.No.116/P of Thadi Village, Parawada Mandal, Anakapalli District subject to the outcome of the afore mentioned court cases and compliance with all applicable rules and regulations; and with a condition that the facility should comply with the EC Order conditions and NGRI recommendations proposed if any along with all other necessary applicable conditions.
