ORDER:

In the G.O 1st read above, Government have published the provisional Seniority List of Additional Superintendents of Police (Civil) for the panel years 2020-2021 & 2022-2023, requesting the affected individuals to submit objections if any, within (15) days from date of issue of the said order.

2. The Director General of Police, Andhra Pradesh in his letter 2nd read above, has informed that the Provisional Seniority List was communicated to all the public servants concerned and upload the provisional list in the official website of Police Department. He also stated that, four Additional Superintendents of Police (Civil) has filed their objections before him and

therefore requested the Government to dispose off the said objections and issue Final Seniority List of Additional Superintendents of Police (Civil).

3. Government vide G.O 3rd read above, while accepting the recommendations of Screening Committee has reviewed and recasted the approved panels of Deputy Superintendents of Police (Civil) who are fit for promotion to the post of Additional Superintendents of Police (Civil) for the panel years 2020-2021, 2022-2023 and 2023-2024, subject to outcome of OAs/CAs/WPs/Was/RPs/SLPs., etc., if any, pending adjudication before the Hon'ble Tribunal/Courts.

4. Government after careful consideration of the review/recast of the approved panels of Deputy Superintendents of Police (Civil) who are fit for promotion to the post of Additional Superintendents of Police (Civil) for the panel years 2020-21, 2022-23, hereby order to publish the final seniority list of Additional Superintendent of Police (Civil) for the panel years 2020-2021 & 2022-2023 along with objections and their disposals vide Annexure-I and II to this order, subject to outcome of any other O.As/W.Ps/pending before the adjudication of Hon'ble APAT/High Court and subject to condition that the notional seniority ordered shall be on the principle of no work, no pay and for the purpose of seniority and promotion only and not for other financial benefits now or in future.

5. The Director General of Police, Andhra Pradesh shall take necessary further action in the matter, accordingly.

Further, directed the DGP, AP to send proposals for promotion of Sri C.Narendranath Reddy to the post of Addl.SP (Civil) on par with his juniors who were already considered for promotion in normal course along with other candidates as per the directions of Hon'ble High Court. Sri C.Narendranath Reddy, DSP was assigned notional seniority at SI.No.1581 in the final Combined Seniority List of Deputy Superintendents of Police (Civil) (AP & TS) (Direct Recruits and Promotees) keeping in view the Hon'ble High Court Common Orders dated 19.9.2017 in W.P.No.9654/2016 and batch
