In exercise of the powers conferred by Sub-Section (1) of Section-12 with Sub-Section (1) of Section 21 of the Andhra Pradesh Civil Courts Act, 1972 (Act 19 of 1972), the Government of Andhra Pradesh, after consultation with the High Court of Andhra Pradesh hereby establish a Court of Civil Judge (Senior Division) at Jangareddigudem in the District of West Godavari as sanctioned in the G.O.Ms.No.65, Law (L and LA&J-Home Courts-A) Department, Dt.06.04.2026, with effect on and from the date on which the Civil Judge (Senior Division) posted assumes charge of the said Court shall sit at Jangarcddigudem.
