NOTIFICATION

In exercise of the powers conferred under section 52 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013 (Act No 30 of 2013), Government hereby appoint the following Presiding Officers U/s.52 of the Act, for Land Acquisition, Rehabilitation and Resettlement Authority for Visakhapatnam and Vijayawada Regions:

(i) Sri P.Bhaskara Rao, Retired District Judge is appointed as Presiding Officer, Land Acquisition Rehabilitation and Resettlement Authority, Visakhapatnam Region, Visakhapatnam duly relieving Sri G.Anwar Basha, Presiding Officer, Land Acquisition, Rehabilitation and Resettlement Authority, Tirupati Region form the full additional charge to the said post.

(ii) Sri T. Venkateswarlu, Retired District Judge is appointed as Presiding Officer, Andhra Pradesh Land Acquisition Rehabilitation and Resettlement Authority, Vijayawada Region, Vijayawada duly relieving Sri G.Anwar Basha, Presiding Officer, Land Acquisition, Rehabilitation and Resettlement Authority, Tirupati Region from the full additional charge to the said post.

2. The above appointed Presiding Officers for the Land Acquisition, Rehabilitation and Resettlement Authorities for Visakhapatnam & Vijayawada Regions will exercise jurisdiction, powers conferred on it under the said Act.

6. The Chief Commissioner of Land Administration, A.P., Mangalagiri shall take further necessary action in the matter accordingly.
