ORDER :

Whereas, as per the records of this office, the date of birth of Sri.S.Md.I.Khaleelulla Saheb, Administrative Officer, O/o.DTCP, AP, Amaravati is 01-06-1964 and accordingly, he has to retire from service on the A.N.of **31-05-2026** on attaining the age of superannuation of (62) years in terms of GO read (9) above.

And whereas, a Retirement Notice has already been issued to him vide memo read (11) above as required under rules.

Now, therefore, in exercise of the powers conferred on the Director of Town and Country Planning, Amaravati and in pursuance of the orders of the Government issued from time to time in respect of retirements of the Government employees on attaining the age of superannuation vide G.Os read (1) to (9) above, following orders are issued:

Sri.S.Md.I.Khaleelulla Saheb, Administrative Officer, O/o.DTCP, AP, Amaravati who is a member of A.P. Town Planning Service is permitted to retire from service on the afternoon of 31-05-2026 on attaining the age of superannuation of (62) years, as per the existing Government orders, inforce, issued in G.O.read (9) above.

The individual is informed that he/she is allowed to retire from service, subject to condition, that, if any disciplinary proceedings that may arise prior to his/her retirement and without prejudice to the right of the Government/ Department, shall continue to be the disciplinary proceedings or judicial proceedings, during his/her service or after retirement, in terms of G.O.Ms.No.171, Finance & Planning Department, dt.01-07-1974 read with F.R 56 (10) (2). Further if he/she is already facing any disciplinary case(s) prior to his/her retirement which comes to the notice of the Department/Government at any later date, the provisions under Article 351-A of Pension Code, Rule.9 of A.P. Revised Pension Rules, 1980 will attract and accordingly the Government reserves the right to regulate Pensionary benefits of the employee even after his/her retirement.

Consequent on retirement, Sri.S.Md.I.Khaleelulla Saheb, Administrative Officer, O/o DTCP, AP, Amaravati is hereby relieved from his duties on the A.N. of 31-05-2026.
