SPORTS POLICY 2024-29 - IMPLEMENTATION OF THREE PERCENT (3%) HORIZONTAL RESERVATION TO MERITORIOUS SPORTSPERSONS IN DIRECT RECRUITMENT ACROSS GOVERNMENT DEPARTMENTS, LOCAL BODIES, PUBLIC SECTOR UNDERTAKINGS (PSUs), AND UNIFORMED SERVICES INCLUDING POLICE, EXCISE, AND FOREST DEPARTMENTS Etc.- REVISED GUIDELINES.

[G.O.Ms.No.25, Youth Advancement, Tourism and Culture (Sps & YS), 15th May, 2026.]

NOTIFICATION

In pursuance of the Sports Policy 2024-29 issued in G.O.Ms.No.18, YAT&C (Sps & YS) Dept., dated 10-12-2024 and in pursuance of the amendment orders issued to the Andhra Pradesh Sports Policy 2024-29 in G.O.Ms.No.23, YAT&C (Sps&YS) Dept., dated 14-05-2026, the Governor of Andhra Pradesh hereby issue the following revised guidelines for governing such appointments, duly superseding the guidelines issued vide G.O. fourth read above :-

This Notification shall come into force with effect from the date of issue of this order.

I. Guidelines

- The Recruitment of eligible meritorious sportspersons under three percent (3%) sports quota shall be based on the Notifications issued by the

concerned Recruiting Agency viz., Andhra Pradesh Public Service Commission (APPSC)/Selection Board/Department concerned etc. The list of Meritorious Sportspersons who qualify in the prescribed Recruitment Examinations conducted by Recruiting agencies will be subject to scrutiny by the Sports Authority of Andhra Pradesh (SAAP). After scrutiny as per the prescribed procedure, the SAAP shall communicate the list of such Meritorious Sportspersons organized in order of priority to the Recruiting Agency concerned.

- b. The three percent (3%) horizontal reservation in direct recruitment under sports quota shall apply to all the Government Departments, Local Bodies, Public Sector Undertakings (PSUs) & Uniformed Services, including the Police, Excise and Forest Departments.
- c. Criteria for deciding the eligible meritorious sportspersons: -
 - i. The sports disciplines mentioned at Serial No.VI of this order are the list of Recognized Sports Disciplines eligible for the purpose of three percent (3%) Horizontal Reservation in direct recruitment.
 - ii. The eligibility criteria, based on the tournament & medals, for the Senior level competitions of sports for employment are listed at Serial No. VII of this order.
 - iii. For filling up of posts which are: -
 - a. under the purview of the Andhra Pradesh Public Service Commission (APPSC), the achievements (Individual & Team) of the meritorious sportspersons shall be considered as per the eligibility criteria indicated at Serial No. VII of this order.
 - b. posts that are not covered under Group – I, II,III&IV services under the purview of APPSC, and those that are outside the purview of the APPSC i.e., to be filled either by the concerned Department, or any Selection Board, or District Selection Committee (DSC), will be considered as per the priority as listed in Serial No. VIII of this order.
 - c. The meritorious sportspersons shall necessarily possess the requisite academic and technical qualifications if any as prescribed in the rules governing the posts.
 - d. The meritorious sportspersons who possess the requisite qualifications have to qualify the eligibility test for appointment.
 - e. The recruiting agencies will notify the qualifying marks for such exams for considering appointment under 3% sports quota.
 - f. The criterion for being considered as Meritorious Sportspersons for appointment under 3% horizontal reservation, shall be the performance of the individual in having obtained medals/participation in sports disciplines as

mentioned in Serial No.VIII of this order read with Serial No.VI of this order, as may be revised by the Government from time to time.

- g. The three percent (3%) sports quota reserved for eligible meritorious sportspersons for Senior level competitions of sports shall be filled in accordance with the priority criteria outlined in Serial No. VIII of this order.
- h. The meritorious sportspersons who are eligible for a particular category of posts, shall be considered as eligible for posts in lower categories also, subject to the fulfillment of specific conditions that shall apply to such posts but not vice versa.

Example: A sportsperson who is eligible for the posts in Group-I services will also be eligible for the posts in Group-II & Group-III/IV services.

II. Role and responsibilities of the Recruiting Agencies –

- a. The concerned Recruiting Agency shall invite applications from the meritorious sportspersons willing to apply under the sports quota. The notification shall clearly specify the terms and conditions, including the eligibility criteria for consideration under the sports quota.
- b. The prescribed forms in which the applicant shall submit his meritorious sports achievement, are appended to this order.
- c. The format in which the details shall be sought from the Meritorious Sportspersons at the time of submission of applications regarding highest sports achievement(s), connected lower level sports achievement(s), relevant forms, undertaking on sports achievement(s) etc., shall be communicated by SAAP to the recruiting agencies.
- d. The Recruiting Agency shall forward the applications of the meritorious sportspersons who have qualified in the eligibility test, to the Sports Authority of Andhra Pradesh within fifteen (15) days from the date of declaration of results, for scrutiny.
- e. The recruiting agency shall implement the 3% Horizontal Reservation under the Sports Quota strictly in accordance with the operational guidelines prescribed in G.O. Ms. No. 77, G.A.(Ser.D) Department, dated 02-08-2023 duly integrating the revised procedures and priorities specified in this order.

III. Role and responsibilities of Sports Authority of Andhra Pradesh (SAAP)

- a. The applications of the meritorious sportspersons who have qualified in the eligibility test, received by SAAP from the recruiting agency, shall be scrutinized by the Screening Committee constituted for this purpose. The composition of the Screening Committee shall be as follows:-

Composition of Screening Committee:-

Chairman	Administrative Officer, SAAP
Members	Two Senior District Sports Development Officers (DSDOs) (nominated by VC & MD, SAAP)
Member	Tribal Sports Officer (TSO), SAAP
Member	Senior Coach, SAAP (nominated by VC&MD,SAAP)
Member	Assistant Director (Technical), SAAP
Any other members may be co-opted as deemed fit by the VC & MD, SAAP	

b. The Committee shall undertake the following: -

- i. To verify as to whether the certificates have been awarded by a competent authority as specified in Section No. IX of this order.
- ii. To ascertain the genuineness of the certificates/ documents from the issuing body.
- iii. To assess the level at which the applicant has participated (e.g., State, National, or International).
- iv. To verify the medals / participation in the competitions / place achieved by cross verification of additional documents such as photographs, official notices, press releases of the event, participants involved, and line up certificates.
- v. The date of the birth, as mentioned in valid certificate produced by the applicant, shall be tallied proportionately to the category of age group vis-a-vis the concerned sport.
- vi. The date of birth shall be determined as follows : -
 - a. If a Board such as SSC, CBSE, ICSE, etc., awards a certificate, the date of birth (DoB) mentioned in the certificate should be considered valid.
 - b. In the absence of certificate issued by a Board, the certificate issued by the competent authority of the "School" only i.e., schools run by autonomous organizations like Kendriya Vidyalaya Sangathan (KVS), Navodaya Vidyalaya Samiti (NVS), Central Tibetan Schools Organisation (CTSO), Sainik Schools Society etc., which are not affiliated to CBSE but are recognized by the respective State Education Departments shall be accepted as proof of age. The certificate issued by any Sports Association or other body will not be accepted as valid proof of age.
 - i. The personal credentials of the meritorious sportsperson provided on the application, birth certificate, and the sports certificate should be the same.

- ii. To verify as to whether the organization that issued the sports certificate is recognized by the appropriate sports governing body. Certificates from unrecognized or unaffiliated organizations shall not be considered valid for employment purposes. The said certificates shall be considered as invalid.
- iii. Resolution of ambiguity and disputes:- In case of any ambiguity, dispute, or doubt in determining priority or eligibility, the Competent Authority shall have the right to take a final decision, duly recording the reasons and minutes for each such case.
- c. The Screening Committee shall prepare a tentative merit list organized in order of priority and forward the same to the concerned Recruiting Agency for publishing in their official website or leading newspaper etc., to invite objections, if any, within 15 days from the date of publication.
- d. All objections received on such tentative merit list by the recruiting agency within the stipulated time shall be forwarded to the SAAP within (15) days. The objections shall be examined by the Screening Committee, and disposed of, duly recording the reasons for acceptance or rejection within 15 days.
- e. The Screening Committee shall prepare a preliminary merit list of the eligible meritorious sportspersons organized in order of priority within 7 days from the date of disposal of objections. Thereafter, the VC & MD, SAAP will furnish the said preliminary merit list to the State Level Committee (SLC) immediately.

IV. Role and responsibilities of State Level Committee - Composition of State Level Committee (SLC)

- a. The composition of the State Level Committee shall be as follows:

i.	Chairman	Special Chief Secretary/Principal Secretary/ Secretary to Government, YAT&C(Sports & Youth Services) Department
ii.	Member	Special Chief Secretary/Principal Secretary/Secretary to Government (Services & HRM), General Administration Department
iii.	Member	Special Chief Secretary/Principal Secretary/Secretary to Government of the concerned Recruiting Department
iv.	Member-Convener	The Vice Chairman & Managing Director, SAAP, A.P., Vijayawada

- b. The VC & MD, SAAP shall convene the State Level Committee meeting immediately on receipt of the preliminary merit list organized in order of priority and place the said list before the State Level Committee.
- c. The Committee shall review the preliminary merit list, as submitted by the Screening Committee, to satisfy itself that the list has been prepared in accordance with the rules stipulated for this purpose.
- d. The Committee shall complete the exercise within a time period, not exceeding 15 days from the date of receipt of the preliminary merit list from VC & MD, SAAP.
- e. The final merit list of eligible meritorious sportspersons organized in order of priority will be approved by the State Level Committee (SLC) and such list shall only be valid for that specific notification.
- f. The approved final merit list shall be communicated by the Convener of State Level Committee, to the Recruiting agency such as APPSC/ Selection Board/ Department concerned / DSC etc.
- g. The Recruiting agency shall integrate the final merit list, communicated by the SLC, of meritorious sportspersons for implementing the horizontal reservation in their merit list.
- h. The final merit list organized in order of priority approved by the State Level Committee shall be final.

V. Other guidelines and general conditions –

- a. Participation at a higher-level tournament shall be considered only when it is supported by winning medals at the lower-level tournament for Individual events only. For Team games, participation at a higher-level tournament shall be considered, atleast, when it is supported by participation (not winning medal) at a lower-level tournament. For this clause, participation certificates, as applicable, need to be produced by the candidate.
- b. If, at any point of time, it comes to the notice of the Competent Authority, that a sports certificate was issued fraudulently by any Sports Association/Federation, necessary legal action against such Sports Association / Federation shall be taken.
- c. Forms issued by Sports Federation/Associations, other than those recognized by the Ministry of Sports and Youth Welfare, Government of India / Sports Authority of India/ Sports Authority of Andhra Pradesh, shall not be considered.

- d. Meritorious Sportsperson recruited against sports quota shall be terminated from service, if the information and documents furnished by him/her for recruitment, are found to be invalid /fake / obtained by fraudulent means, at any stage, as per the rules in vogue.
- e. Every candidate, at the time submitting his application, shall be required to submit a declaration in the prescribed format that all the documents filed as a part of his application are true to the best of his knowledge and belief and further that such candidate shall be liable for criminal / disciplinary action, if a violation is noticed by the competent authority.
- f. The candidates appointed to a Department under sports quota, shall represent such Department for at least 10 years from the date of appointment in sports competitions to be conducted at State, National and International levels.
- g. The meritorious sportsperson shall be eligible only if they have represented the State of Andhra Pradesh in recognized sports events. The benefit of reservation under the Sports Quota shall be extended only to candidates who possess local status in the State of Andhra Pradesh.
- h. Participation requirements for team sports players including Stand-by/Substitutes: - "In regard to team sports, the sports persons must have played in not less than 50 % of the games played by the teams in that recognized tournament for consideration under the 3% Horizontal Reservation (Sports Quota) for Direct Recruitment, for which relevant proof such as participants lists, entry form along with playing photos as main player shall be submitted". The players who have taken part in the tournament as Manager/Coach/Mentor etc cannot be considered for this purpose.
- i. Mandatory Registration in "sports.ap.gov.in" or any other digital platform/software tool developed and maintained by SAAP. "All sportspersons seeking benefit under the 3% Horizontal Reservation (Sports Quota) shall mandatorily register and upload their eligible sports achievements in "sports.ap.gov.in" or any other digital platform/software tool developed and maintained by SAAP. Only verified entries in the said platform shall be considered for recruitment purposes."
- j. Not considering Unauthorized Tournaments:- Medal/Participation in Open / Invitation / Selection Trials / Camps / or any unauthorized/un-recognised tournaments or meets shall not be considered for the award of priority for employment under 3% horizontal reservation (sports quota).

The following criteria shall also be taken into consideration in determining the priority list.

- a. Priority will be given based on the level of sports achievement as per the priority list prescribed at Section-VIII for the best achievement made by the meritorious sportsperson during the eligible period.
- b. Resolution of Tie Cases:- In the event of a tie between two or more candidates holding equal priority at the highest level.
 - i. Preference shall be given to the candidate having a greater number of similar high-level sports achievements.
 - ii. If the tie persists, preference shall be given to the candidate possessing a greater number of sports achievements at the next lower level.

- iii. If the tie still persists, preference shall be given to the candidate who is elder in age.
