ORDER:

The Waqf Institution Mosque Sunni situated at Vedurmudi Village, Kapileshwrapuramu Mandal, Dr.BR Ambedkar Konaseema District (Erstwhile East Godavari District) is a notified Waqf and got published in A.P.Gazette No.16, dated:19-04-1962 at Serial No.277 in page No. 460 & 461 and addendum notification No.15, dated:14-04-2016. As per Addendum notification the said institution is having attached lands at Vedurmudi in TD.No.1270 covered in Sy.Nos.17, 31/6, 58/1, 3/2 and 4 total to an extent of Ac.18.03 cts, under the Towliath of Sheik Hyder Saheb. The Rule of succession to the office of the Mutawalli specified as hereditary.

In the ref.1st read above, Board's authorities are appointed Sri.Shaik Abdul Khader Jilani, S/o. late Shaik Hyder Saheb as Mutawalli U/sec.42 of Waqf Act, 1995 to the subject Waqf institution and the said Mutawalli was expired on 14-05-2021.

In the ref.2nd read above, Sri Shaik Hyder, S/o. late Shaik Abdul Khader Jilani, has submitted representation Dated:07-06-2022, wherein he has informed that his father Sri.Shaik Abdul Khader Jilani was Mutawalli of the subject Mosque and he was expired on 14-05-2021 and he assumed the charge of the institution and requested to recognize him as Mutawalli U/sec.42 of Waqf Act, 1995 to the subject institution in place of his father.

With regards to the above the Inspector Auditor Waqfs, Dr.BR Ambedkar Konaseema District has submitted report dated:20-08-2022 vide ref.3rd read above, that Sri Shaik Hyder, S/o. late Shaik Abdul Khader Jilani is son of late Mutawalli and the attached land of the institution are under encroachment, there is no income to the Mosque and there is no structure of Mosque in Vedurimudi Village only Vacant place is there and requested to appoint him as Mutawalli.

Further this office has issued paper notification dated: 07-11-2022 vide ref.4th read above, for calling claims and objections if any for recognition of Sri Shaik Hyder, S/o. Sri.Shaik Abdul Khader Jilani as Mutawalli U/sec.42 of Waqf Act, 1995 to the subject Waqf institution and its attached properties may file their claims and objection within a period of (15) days from the date of Publication of this Notification.

Consequently the Inspector Auditor Waqf, Dr.BR Ambedkar Konaseema District has reported vide ref.5th read above, that the above said paper notification Dated: 07-11-2022 has been published in Eenadu Telugu daily Mandapeta edition of on 11-11-2022 and there were no claims & objections received against the said notification and also this office not received any objection.

Further the above said matter was placed before the then Board and the Board has passed resolution No.679/2023, Dated:03-02-2023 vide ref.6th read above, that " defer the matter for the subsequent meetings".

Further this office has issued intimation dated:06-11-2025 vide ref.7th read above, with a direction to the applicant for personal appearance before the Hon'ble Chairperson of APSWB and the said applicant has attended before the Hon'ble Chairperson on 20-11-2025 and the discussed with the encroachment and attached properties of the institution.

Further in the ref.8th read above, the Inspector Auditor Waqfs has submitted report that at present there is no Mosque has constructed and having vacant land in to an extent of Ac.0.15 cts in D.No.2-65 in Sy.No.109 of Vedurumudi (V) Kapilesawarapuram (M), Dr. B.R. Ambedkar Konaseema District and Sri Shaik Hyder S/o. Abdul Khader Jeelani is looking affairs of the subject institution and WP No.5520 of 2020 & CC No.426 of 2023 has filed by the applicant against the Revenue Authorities for not approval of Mosque plan and the same is still pending before the Hon'ble High Court. Further the Inspector Auditor Waqfs has reported that Institution is having attached lands total to an extent of Ac.18.03 cts in Sy.No.3/2, 4, 17, 31/6 & 58/1 of Vedurimudi (V) and the total lands is under encroachment, the Board has initiated action U/sec.51 of Waqf Act for recovery of the Waqf property and the encroachers have filed (5) Writ Petitions vide WP No.1673 of 2012, WP No.10655 of 2012, WP No.22071 of 2013, W.P. No.22946 of 2013 & WP No.23561 of 2013 before the Hon'ble High Court of AP and the Board has filed Counters in the above Cases which are pending before the Hon'ble high Court of AP.

Finally the Inspector Auditor Waqfs, Dr.B.R.Ambedkar Konaseema District has requested to issue directions to the District Revenue Authorities of Dr. B.R.A.K. District to accord permission for reconstruction of the mosque at the above Waqf land at Vedurmudi (V) Kapileswapuram and also further requested to appoint Sri Shaik Hyder as Mutawalli U/Sec.42 of Waqf Act,1995 as hereditary Mutawalli to the subject institution as he is looking the day to day affairs of the subject institution from the ancient times.

The entire matter was placed before the Board in its meeting held on 10-02-2026 and the Board unanimously resolved resolution that " to recognized Sri Shaik Hyder S/o late Shaik Abdul Khader Jeelani as Mutawalli to the subject institution U/sec. 42 of UWMEED Act,1995 " vide resolution No.380/2026, Dated: 10-02-2026 vide ref.8th read above.

Accordingly, Sri Shaik Hyder S/o late Shaik Abdul Khader Jeelani is hereby recognized as Mutawalli U/Sec.42 of UWMEED Act,1995 as amended by the Waqf (Amendment) Act, 2025 to the Waqf institution Masjid situated Vedurumudi (V), Kapileswarapuram (M) Dr.B.R.Ambedkar Konaseema District (Erstwhile East Godavari District) to manage the day to day affairs of the subject institution and its attached Waqf properties by following the UWMEED Act, 1995 as amended by the Waqf (Amendment) Act, 2025 and subsequent Waqf Rules made therein.

The Mutawalli should discharge his legitimate duties strictly as determined in Section 50 of Unified Waqf Management, Empowerment, Efficiency and Development Act, 1995 as amended by the Waqf (Amendment) Act,2025 read with A.P. Waqf Rules, 2023 and should follow the instructions issued by the Board from time to time and should submit the Accounts U/sec.46, Budget U/sec.44 and pay the Waqf fund to the Board every year duly following the provisions laid down U/sec.72 & 77 of Unified Waqf Management, Empowerment, Efficiency and Development Act,1995 as amended by the Waqf (Amendment) Act,2025 properly. Failing which action will be taken against him U/Sec.61 and 64 as read the afore mentioned (Amendment) Act, 2025 and the duties mentioned below:

- a) To implement the orders issued by the Board from time to time.
- b) To carry out the directions of the Board, to allow inspection of the Inspector Auditor, Waqfs regarding property, accounts, records, deeds and documents relating thereof
- c) To discharge all public duties. To do any other Act which he is Lawfully required to do so or under this Act.
- d) He shall render proper and correct accounts of the Institution and its attached properties and shall not suppress any facts.
- e) The Mutawalli should follow the Norms fixed under Section 56 of Unified Waqf Management, Empowerment, Efficiency and Development Act, 1995 as amended by the Waqf (Amendment) Act, 2025 while granting Lease of any agricultural lands. He should follow Lease Rules, 2014 while leasing of attached Waqf properties through A.P. State Waqf Board and also shall follow the Rule 15 made of the Waqf properties lease Rules 2014.
- f) The Mutawalli shall open account in any Nationalized Bank and all the transactions shall be reflected therein.
- g) Further subject to the condition that if any future claims / objections are received on the said Hereditary-ship appropriate decision will be taken as per law.

As per Sec.101(2) of Unified Waqf Management, Empowerment, Efficiency and Development Act, 1995 as amended by the Waqf (Amendment) Act, 2025 " every Mutawalli of a Waqf, every member of Managing Committee whether constituted by the Board or under any deed of Waqf, every Executive Officer and every person holding any office in a Waqf shall also to be deemed as a public servant within the meaning of "Clause (28) of section 2 of the Bhartiya Nyaya Sanhita, 2023". As such, for the illegal acts if any, every member of the committee will be liable for penal action. The Mutawalli shall also noted that Sec.3(ee) defined encroacher, and also penalty for alienations of Waqf property without sanction of the Board shall be punishable with (imprisonment) for a term which may extend to (2) years U/sec.52-A and section 61 speaks penalties for the lapses/ charges shown therein, hence should act carefully, diligently and maintain accounts scrupulously as specified under this Act.
