ORDER:

The post of Deputy Director of Fisheries constitutes under Category (3), Class-1 of Rule 2 of the Andhra Pradesh Fisheries Service Rules, 1991. Under Rule 3 of the said rules, the method of appointment for the post of Deputy Director of Fisheries is by way of promotion from the category of Assistant Director of Fisheries (Category (4) of Class-1) and the Government is the appointing authority for the said post.

2. The Commissioner of Fisheries, A.P., Vijayawada in the letter 1st read above has requested the Government to finalize the Seniority in the cadre of Deputy Director of Fisheries, which comes under Category (3) of Class-I for the period of 2022-23.

3. In the Memo 2nd read above, Government communicated the provisional seniority list of Deputy Director of Fisheries, who were promoted from Assistant Director of Fisheries during the period of 2022-23, to the concerned officers/effectuated parties for making representations/ objections, if any, against the provisional seniority within 15 days from the date of Communication. The Commissioner of Fisheries, Vijayawada was requested to obtain objections from the individuals, if any, and furnish the same along with his specific remarks with reference to rule position on the objections, to Government for further examination.

4. In the reference 3rd read above, the Commissioner of Fisheries, Vijayawada has submitted that no objections were received so far and requested the Government to issue orders for finalization and publication of seniority list of Deputy Director of Fisheries.

5.
