KURNOOL DISTRICT - IMDAD ALI SAHEB MASJID @ KNOWN AS MASJID-E-MOULANA SITUATED AT CHATRIBAGH, KURNOOL CITY - Sri SHAIK MOHAMMED SANAULLAH S/o.D.SHALI MIAH APPOINTED AS MUTAWALLI U/Sec.63 OF UWMEED ACT, 1995 AS AMENDED BY THE WAQF (AMENDMENT) ACT, 2025 FOR A PERIOD OF TWO (2) YEARS.

ORDER:

The Waqf institution namely Imdad Ali Saheb Masjid @ known as Masjid-e-Moulana situated at Chatribagh, Kurnool City & District is a notified Waqf and got published in A.P. Gazette No.43-A, Dated:24-10-1963 at Serial No.3110 under the Towliath of Shahzadi Bee and the Rule of succession to the office of the Mutawalli specified as Hereditary by Custom.

In the ref 1st read above, a representation has been received from Sri Shaik Mohammed Sanaullah, R/o. Kurnool City & District, wherein informed that earlier (30) years ago the subject Masjid was very old condition he was reconstructed & developed the Masjid with his own funds, paying Mouzzans salaries, Electricity Bills, water bill, Municipal taxes etc and requested to appoint him as Mutawalli to the subject institution.

With regards to the above the Inspector Auditor Waqfs, Kurnool District has submitted his report vide ref.2nd read above, that the institution is not having any attached properties, there are no where about of legal heirs of notified Mutawallies and the subject Masjid being managed by the family of the applicant since inception i.e., D.Shali Miah (who is father of the applicant) after his death his son i.e. the applicant Sri Shaik Mohammed Sanaullah S/o. D. Shali Miah is managing the entire affairs of the subject Masjid Paying Electricity bills, Salaries to Pesh Imam & Mouzzan, the applicant also renovated the Masjid, there is no any disputes in Masjid, the Mussallies of the subject Masjid have submitted their statement and recommending the candidature of the applicant for appointment of Mutawalli to the subject Masjid and also stated that there is no anywhere about of the legal heirs of notified Mutawalli since inspection. And requested to consider the request of the applicant Sri Mohammed Sanaullah S/o. D.Shali Miah for appointment of Mutawalli of the subject Masjid.

Further this office has issued paper notification, Dated:31-03-2026 vide ref.3rd read above, for calling claims and objections if any for appointment of Sri Shaik Mohammed Sanaullah S/o D.Shali Miah as Mutawalli U/sec.63 of UWMEED Act,1995 as amended by the Waqf (Amendment) Act, 2025 for Imdad Ali Saheb Ki Masjid @ known as Masjid-e-Moulana situated at Chatribagh, Kurnool City within a period of (15) days.

With regards to the above the Inspector Auditor Waqfs, Kurnool District has submitted his report vide ref.4th read above, that the above said paper notification was affixed on the notice Board of the subject institution and the District Office and the said notification has been published in Andhra Jyothi Telugu news paper in District edition on 02-04-2026 and there are no claims / objection received against the said notification and requested to appoint him as Mutawalli to the subject institution.

The entire matter was placed before the Board in its meeting held on 21-04-2026 after careful examined the matter and the Board “ unanimously resolved to appoint Sri Shaik Mohammed Sanaullah S/o D.Shali Miha as Muthawalli U/sec.63 of UWMEED Act, 1995 for a period of (2) years to the subject Waqf institution” vide resolution No.424/2026, Dated:21-04-2026 vide in the ref.5th read above.

Accordingly, Sri Shaik Mohammed Sanaullah S/o D.Shali Miha is hereby appointed as Mutawalli U/sec.63 of the UWMEED Act,1995 as amended by the Waqf (Amendment) Act,2025 for the Waqf Institution Imdad Ali Saheb Masjid @ known as Masjid E Moulana situated at Chatribagh, Kurnool City & District for a period of two (2) years to manage the day to day affairs of the subject institution from the date of issue of this orders by following the UWMEED Act,1995 as amended by the Waqf (Amendment) Act, 2025 and Waqf Rules made therein.

The Mutawalli should discharge his legitimate duties strictly as determined in Section 50 of Unified Waqf Management, Empowerment, Efficiency and Development Act, 1995 as amended by the Waqf (Amendment) Act, 2025 read with A.P. Waqf Rules, 2023 and should follow the instructions issued by the Board from time to time he should submit the Accounts U/sec.46 of the UWMEED Act,1995 as amended by the Waqf (Amendment)Act,2025 and Budget U/sec.44 of the UWMEED Act,1995 as amended by the Waqf (Amendment) Act, 2025 and pay the Waqf fund to the Board every year duly following the provisions laid down U/sec.72 & 77 of the UWMEED Act,1995 as amended by the Waqf (Amendment) Act, 2025 properly, failing which action will be taken against him U/Sec.61 and 64 of the UWMEED Act,1995 as amended by the Waqf (Amendment) Act, 2025 as the duties mentioned below:

- a) To implement the orders issued by the Board from time to time.
- b) To carry out the directions of the Board, to allow inspection of the Inspector Auditor, Waqfs regarding property, accounts, records, deeds and documents relating thereof.
- c) To discharge all public duties. To do any other Act which he is Lawfully required to do so or under this Act.
- d) He shall render proper and correct accounts of the Institution and its attached properties and shall not suppress any facts.
- e) The Mutawalli should follow the Norms fixed under Section 56 of Unified Waqf Management, Empowerment, Efficiency and Development Act,1995 as amended by the Waqf (Amendment) Act,2025 while granting Lease of any agricultural lands. He should follow Lease Rules, 2014 while leasing of attached Waqf properties through A.P. State Waqf Board. The Mutawalli shall take steps to evict illegal encroachers from the Waqf lands.
- f) The Mutawalli shall open account in any Nationalized Bank and all the transactions shall be reflected therein.
- g) Further subject to the condition that if any future claims / objections are received on the said hereditary-ship, appropriate decision will be taken as per law.

As per Sec.101(2) of Unified Waqf Management, Empowerment, Efficiency and Development Act,1995 as amended by the Waqf (Amendment) Act, 2025 “ every Mutawalli of a Waqf, every member of Managing Committee whether constituted by the Board or under any deed of Waqf, every Executive Officer and every person holding any office in a Waqf shall also to be deemed as a public servant within the meaning of “Clause (28) of section 2 of the Bhartiya Nyaya Sanhita, 2023 “. As such, for the illegal acts if any, every member of the committee will be liable for penal action. The Mutawalli shall also to note that, Sec.3 (ee) defined encroacher, and also penalty for alienations of

Waqf property without sanction of the Board shall be punishable with (imprisonment) for a term which may extend to (2) years U/sec.52-A and section 61 speaks penalties for the lapses / charges shown therein, hence should act carefully, diligently and maintain accounts scrupulously as specified under this Act.
