TRANSFER OF POWERS AND FUNCTIONS OF POGURUPALLI GRAM PANCHAYAT, GUDUPALLI MANDAL, CHITTOOR DISTRICT TO ANDHRA PRADESH INDUSTRIAL INFRASTRUCTURE CORPORATION LIMITED (APIIC) FOR FORMATION OF INDUSTRIAL AREA LOCAL AUTHORITY (IALA) TO AN EXTENT OF Ac.54.86 Cts UNDER SECTION 147 OF THE A.P. PANCHAYAT RAJ ACT, 1994 (ACT No.13 OF 1994).

NOTIFICATION

In exercise of the powers conferred under Section 147 of the Andhra Pradesh Panchayat Raj Act, 1994 (Act No.13 of 1994) and in consultation with the Pogurupalli Gram Panchayat, Gudupalli Mandal, Chittoor District, the Government hereby transfer the following powers and functions in respect of land an extent of Acs.54.86 cents of Pogurupalli Gram Panchayat in the following survey numbers and the ratio for revenue share is fixed as 50:50 between the Gram Panchayat and the APIIC, so as to maintain civic amenities and for facilitation of speedy industrialization subject to condition that if any environmentally sensitive and fragile areas like water bodies exist, they should not be disturbed under any circumstances and should be allowed to continue their natural course.
