PRELIMINARY NOTIFICATION

The following draft amendments to the Tirumala Tirupati Devasthanams Employees Service Rules, 1989, issued in G.O.Ms.No.1060, Revenue (Endts.I) Department, dated the 24th October, 1989 and published in the Rules supplement to Part-I Extraordinary of the Andhra Pradesh Gazette, dated the 26th October, 1989, as amended subsequently from time to time, which are proposed to be made in exercise of the powers conferred by sub-section (3) of Section 106 and sub-section (4) of Section 107 read with section 153 of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 (Act 30 of 1987) are hereby published for the general information in the Andhra Pradesh Gazette as required under sub-section (1) of Section 153 of the said Act.
