In exercise of the powers conferred under Section 65(2)(a) and (p) of the Motor Vehicles Act, 1988, read with Rule 55G of the Central Motor Vehicles Rules, 1989, the Government of Andhra Pradesh hereby designate the following authorities as Appellate Authorities for hearing appeals as per procedure laid down in Rule 55H of the Central Motor Vehicles Rules, 1989;

- i. Against orders passed by the Registering Authority under Rule 55A of the Central Motor Vehicles Rules, 1989.
- ii. Against orders passed by the Transport Commissioner (Head of the Department) under Rule 55F of the Central Motor Vehicles Rules, 1989.
