ORDER:-

In the reference 1st cited the seniority of Sri D.Sreenivasula Reddy, was finalized in the integrated seniority list of GSTO and placed his name at name at Sl. No. 20 above the name of Smt T.N.Archana at SL.No.21. Consequently, the zonal seniority list of DCTOs of Zone-IV for the panel year 2008-2009 was finalized in the reference 2nd cited, wherein the name of Sri D.Sreenivasula Reddy was missed and not figured above the name of Smt. T.N.Archana.

2. In the reference 4th cited, objections were called for from the effected persons on the inclusion of the name of D. Sreenivasula Reddy at Sl. No. 33-A in the finalized seniority list of DCTO of Zone-IV for the panel year 2008-2009, issued in the reference 2nd cited. On this proposal, no objections was received and accordingly finalized the seniority of Sri D.Sreenivasula Reddy, DCTO vide reference 5th cited duly placing his name at Sl.No. 33-A.

3. In the reference 3rd cited, the state wide provisional integrated seniority list of DCTOs for the panel year 2008-2009 was finalized, basing on the zonal seniority lists of DCTOs of all zones for the panel year 2008-2009. In this said list also the name of Sri D.Sreenivausla Reddy, DCTO was not figured.

4. Since the name of Sri D.Sreenivasula Reddy was included in the zonal seniority list of DCTOs of Zone-IV in the reference 5th cited, his name has to be included at appropriate place in the provisional integrated seniority list of DCTOs for the panel year 2008-2009 finalized in the reference 3rd cited.

5. Accordingly, as per the marks obtained by Sri D.Sreenivasula Reddy, DCTO, it is proposed to include his name at Sl.No. 90-A above the name of Sri Srinivasa Suresh Prasad Babu Krothapalli whose name was placed at Sl.No.91 in the provisional integrated seniority list of DCTOs for the panel year 2008-2009 finalized in the reference 3rd cited, duly deleting the name of Sri A.Maheswar in the said provisional integrated seniority list as shown below:

Accordingly, in the reference 6th cited a Show Cause Notice was issued calling for written objections, if any, from the effected persons regarding the inclusion the name of Sl.No. 90-A above the name of Sri Srinivasa Suresh Prasad Babu Krothapalli whose name was placed at Sl.No.91 in the provisional integrated seniority list of DCTOs for the panel year 2008-2009 finalized in the reference 3rd cited, duly deleting the name of Sri A.Maheswar in the said provisional integrated seniority list. No objections were received to the proposed inclusion.

7. Therefore, the Show Cause Notice issued for inclusion of the name of D.Srinivasulu Reddy at Sl.No. 90-A above the name of Sri Srinivasa Suresh Prasad Babu Krothapalli whose name was placed at Sl.No.91 in the provisional integrated seniority list of DCTOs for the panel year 2008-2009 finalized CCTs Ref.No. DXZ(1)/52/2023 dt:4-8-2023, duly deleting the name of Sri A.Maheswar in the said provisional integrated seniority list is hereby finalized, subject to the outcome of court cases, if any, pending before the competent authority.

8. It may be noted that the placements made in the panel years of the individuals are only for the purpose of seniority and promotions and shall not confer any monetary benefits whatsoever. No retrospective financial benefits can be claimed from the date of inclusion of the individuals in the panels
