KURNOOL DISTRICT - MASJID KNOWN AS JALI BAGH MASJID AND ITS ATTACHED PROPERTIES ARE SITUATED AT KURNOOL CITY - TO TAKE THE INSTITUTIONS AND ITS ATTACHED PROPERTIES UNDER DIRECT MANAGEMENT U/Sec. 65(5) OF THE UNIFIED WAQF MANAGEMENT, EMPOWERMENT, EFFICIENCY AND DEVELOPMENT ACT, 1995 AS AMENDED BY THE WAQF (AMENDMENT) ACT, 2025.

ORDER:

The Waqf institution namely Jali Bagh Masjid is notified Waqf and got published in AP Gazette No.43-A, Part-II, Dated:24-10-1963 at Serial No.3160 in Page No.34 & 35 under the Towliath of Mujawar Masoon Miah and the Rule of the succession to the office of the Mutawalli specified as hereditary and addendum also issued Dated:20-03-1975 for the word nil of attached properties read as lands TD.No.3622 Sy.No.611 to an extent of Ac.44.85 cts.

In the ref.1st read above, the Board has appointed Sri.Mohd.Ibrahim S/o.Mohd.Ismail as Mutawalli to the subject institution and its attached properties with a direction that the alienated / encroached property attached to the institution shall be recovered by him and the said Mutawalli was expired on 13-12-2017.

After the death of Sri.Mohd.Ibrahim S/o.Mohd.Ismail, Mutawalli his son Sri.Md.Ismail S/o.Md.Ibrahim has filed a representation dated:26-12-2017 vide ref.2nd read above, with a request to appoint him as Mutawalli to the subject institution in place of his father.

While the matter stood thus, on the basis of report of the Inspector Auditor Waqfs, Kurnool District, this office has issued paper notification dated:11-09-2018 vide ref.3rd

read above for calling claims and objection if any for appointment of Sri Md.Ismail S/o.Md.Ibrahim within a period of (15) days from the date of publication of this notification.

In the ref.5th read above representations received from Sri Shaik Shabbir Basha S/o Shaik Ismail Basha, stating that he belongs to notified Mutawalli family and requested to appoint him as Mutawalli to the subject institution and filed complaints against Sri.Md.Ismail S/o.Md.Ibrahim with regard misusing of Honorarium of Imam & Mouzan etc.

The reports submitted by Inspector Auditor Waqfs, Kurnool vide ref.6th read above, that a notification dated: 11-09-2018 has been published in Andhra Prabha (local edition) dated 15-09-2018, inviting claims and objections for appointment of Sri Md.Ismail S/o.Md.Ibrahim as Mutawalli but Sri Shaik Shabbir Basha S/o Shaik Ismail Basha has filed objection on 16-09-2018, that Sri Shaik Mohammed Ismail filed a Writ Petition in the Hon'ble High Court, Hyderabad, seeking registration of Waqf land in Sy.No.611/28B to an of Ac.31.13 cents situated at Kallur (V&M),

Kurnool District, claiming it as Inamdar land, which is highly objectionable, unlawful, illegal, and amounts to a serious violation and requested to stop further process for appointment.

Further the Inspector Auditor Waqfs, Kurnool District has stating that the present applicant Sri Shaik Shabbir Basha S/o. Shaik Ismail Basha has submitted an application, dated:06-11-2025 stating that his grandfather, Sri.Mujawar Masoom Basha, had served as Muthawalli of Jali Bagh Masjid, after his demise, his son Sri Shaik Ismail Basha looked after the affairs of the Masjid, and thereafter, the applicant himself has been continuing to render services towards the Masjid and the Musallies of Jali Bagh Masjid have also requested to appoint Sri Shaik Shabbir Basha as Mutawalli.

Further reported that Sri Shaik Shabbir Basha has submitted an objection petition, dated 27-02-2024 against Sri Mohammed Ismail who is misusing Imam & Mouzan Honorarium due to which the Bank account is freezed by the office of Kurnool District further the both of the applicants filed rival claims and complaints against each other in respect of the subject institution and requested to appoint a Senior officer to conduct detail enquiry in this matter.

The above matter was placed before Board meeting in its meeting held on 16-12-2025 and unanimously resolved resolution to authorize the Hon'ble Chairperson, APSWB to call the applicants for personal hearing and to ascertain the details of the Institution and its attached properties vide ref.7th read above.

Accordingly, this office has issued intimation to both the applicants vide ref.8th read above and the said applicants appear before the Hon'ble Chairperson and discussed with detailed.

Further the entire matter was placed before the Board in its meeting held on 21-04-2026 and the Board unanimously resolved vide ref.9th read above that " to take the institution and its attached properties under direct management of AP State Waqf Board U/sec.65 of UWMEED Act,1995. Further resolved to appoint the Inspector Auditor Waqfs, Kurnool District as Executive Officer to the subject Waqf institution to look after the day to day affairs of the Mosque."

Accordingly, the Inspector Auditor Waqfs, Kurnool District is hereby directed to take over / assume the charge of the subject institution and its attached properties under direct management of Waqf Board U/sec.65(5) of UWMEED Act,1995 as

amended by the Waqf (Amendment) Act, 2025 and to look after the day to day affairs & maintain accounts etc of the subject institution till further orders and report compliance, further authorized to open separate Bank account in any nationalized Bank in the name of the subject institution.
