NOTIFICATION

Under Rule 10(a) of Andhra Pradesh State and Subordinate Service Rules, 1996, the following Tahsildars are hereby appointed to the cadre of Deputy Collector on promotion (Category-II) of Andhra Pradesh Civil Services (Executive Branch) Rules, 1992 on purely temporary / ad-hoc basis for the panel year 2025- 2026 in the Revised Pay Scales-2022 of Rs.61960- 151370.

The above appointment by promotion / appointment by transfer ordered on purely temporary / ad-hoc basis and are subject to the following conditions:

- i. the placement of officers as shown above (i.e., Sl. No. & Roster point) is not based on the seniority.
- ii. the above Tahsildars considered for ad-hoc / temporary promotions / transfers for the post of Deputy Collectors will be cleared by the Departmental Promotion Committee in the regular panels to be conducted in future based on their seniority.
- iii. the appointment is purely temporary under emergency provisions and does not confer any right of any kind on the individual who is liable to be reverted at any time without prior notice and without assigning any reasons thereof and the excess amount drawn, if any, in this category will be recovered;
- iv. the officer shall not be regarded as a Probationer or be entitled by reason only of such appointment to any preferential claim for future appointment to such service, class or category. Their services will be regularized against the substantive vacancy meant for them only, till such time the officer has to work on temporary / ad-hoc basis in the cadre of Deputy Collector;
- v. the adhoc promotions accorded are subject to outcome of pending O.As/W.Ps/ SLPs, respectively and any other cases pending before any court of law;
- vi. the appointment is also subject to joining of the Officer in the promoted post within the stipulated time of 15 (fifteen) days from the date of receipt of the order (i.e. Promotion & Posting) as specified in rule 11(b) of A.P. State & Subordinate Service Rules, 1996, failing which he/she would forfeit the right of promotion / appointment by transfer to the cadre of Deputy Collector.
- vii. the posting orders to the above officers will be issued separately by the General Administration (SC.B) Department based on the vacancies available, till such time they shall continue in their present post / place of working.
- viii. the General Administration (SC.B) Department shall take necessary action for issuing posting orders soon after completion of the revision of Electoral Rolls in the Special Intensive Revision (SIR) or in consultation with the GA (Elections) Department.

The District Collectors concerned are therefore requested to relieve the Tahsildars concerned, only on their posting as Deputy Collector only, so as to enable them to joining in their new assignment.

The Chief Commissioner of Land Administration, A.P., Mangalagiri shall take necessary further action in the matter accordingly.
