**ORDER :**

Whereas, as per the records of this office, the date of birth of Sri.P.Ammaji Rao, Assistant Director of Town Planning, working on deputation as Assistant Planning Officer,, VMRDA, Visakhapatnam is 08-06-1964 and accordingly, he has to retire from service on the A.N.of **30-06-2026** on attaining the age of superannuation of (62) years in terms of GO read (8) above.

And whereas, a Retirement Notice has already been issued to him vide memo read (12) above as required under rules.

Now, therefore, in exercise of the powers conferred on the Director of Town and Country Planning, Amaravati and in pursuance of the orders of the Government issued from time to time in respect of retirements of the Government employees on attaining the age of superannuation vide G.Os read (1) to (8) above, following orders are issued:

Sri.P.Ammaji Rao, ADTP/APO, VMRDA, Visakhapatnam who is a member of A.P. Town Planning Service Rules is permitted to retire from service on the afternoon of 30-06-2026 on attaining the age of superannuation of (62) years, as per the existing Government orders, inforce, issued in G.O.read (8) above.

He is informed that as per records of this office, he is facing disciplinary case(s) as mentioned in the references cited (9 & 11) and hence he is not entitled to draw the Pensionary benefits like D.C.R.G. and commutation and other terminal benefits etc. till the finalization of disciplinary proceedings pending against him under Article 351-A of Pension Code, Rule.9 of A.P. Revised Pension Rules, 1980 even after retirement. However he is eligible for Provisional Pension only as per norms.

Further, he is allowed to retire from service subject to condition, that, if any other disciplinary proceedings that may arise prior to his retirement and without prejudice to the right of the Government / Department, will continue to be the disciplinary proceedings or judicial proceedings, during his service or after retirement, in terms of G.O.Ms.No.171, Finance & Planning Department,dt.01-07-1974 read with F.R 56 (10) (2).

The Metropolitan Commissioner, VMRDA, Visakhapatnam shall take necessary action accordingly and to relieve said Sri.P.Ammaji Rao, ADTP/APO, on the afternoon of **30-06-2026**, duly making internal arrangements and intimate the same to this office for reference and record.

The Statistical Officer/Drawing and Disbursement Officer (FAC), Accounts Section, O/o.DTCP, AP, Amaravati is hereby directed to take necessary action for sanction of pensionary benefits as per rules in vogue to the above individual, since while working on deputation the individual is going to retire from service on the A.N. of 30-06-2026.
